**JUDGMENT IN A CIVIL CASE**

This action came to trial before the Court, the Honorable David C. Norton presiding. The issues have been duly tried and a decision has been duly rendered.

**IT IS ORDERED AND ADJUDGED** that the Plaintiff, DIRECTV Inc., is awarded statutory damages totaling TWENTY THOUSAND AND 00/100 (\$20,000) DOLLARS, with the additional interest at the rate of 2.20% percent as provided by law.

**IT IS FURTHER ORDERED AND ADJUDGED** that the Defendant, Ed Dixon, is permanently enjoined from violation of 47 USC 605.

**IT IS FURTHER ORDERED AND ADJUDGED** that the Plaintiff is awarded attorney's fees in the amount of TWENTY-FOUR THOUSAND EIGHT HUNDRED FIFTY-ONE AND 50/100 (\$24,851.50) DOLLARS, with the additional interest at the rate of 2.20% percent as provided by law.

**IT IS FURTHER ORDERED AND ADJUDGED** that the Plaintiff is awarded its costs in the amount of TWO THOUSAND SIX HUNDRED SEVENTY-NINE AND 34/100 (\$2,679.34) DOLLARS, with the additional interest at the rate of 2.20% percent as provided by law.
